HOLD HARMLESS AGREEMENT
for Participants of Park Programs and Events

Park University insurance programs do **not** provide accident or sports injury benefits to students who are participating in Park University-sponsored student activities, intramural sports, service learning, community service, student club events, study abroad trip, or other academic or co-curricular program. Some coverage **is provided** for students who are participating in mandatory activities – such as varsity athletes participating in required games and practices and students participating in activities required for a class – as long as students are participating appropriately and following established guidelines and directions.

Curricular and co-curricular student programs have inherent risks which must be assumed by the participants. All participants 18 years or older must legally assume responsibility for their personal safety and health. All Participants under the age of 18 must have the signature of a parent or guardian who is assuming legal responsibility for them.

Event/Trip Sponsors and/or Park University employees will advise you on appropriate actions to safely allow your involvement in the event. However, it is **your** responsibility to use good judgment about your personal actions while involved in this activity.

Participant, by signing below, shall hold Park University and its agents harmless and indemnified from any injury, loss or damages with respect to bodily injury while participating in Park University-sponsored activities and events. Participant assumes sole responsibility for all risks involved that may arise out of any occurrence and in no event shall hold Park University responsible irrespective of any negligence.

Student Conduct Code
